BJFEZA celebrates its 6th anniversary

March 12th-The Busan-Jinhae Free Economic Zone celebrated its 6th anniversary. Song Geun-il, the Deputy-Commissioner of the BJFEZA and some 150 employees participated in the event with an awards ceremony for employees who've made significant contributions to the development of the Busan-Jinhae Free Economic Zone.

Looking back over the last 6 years much has been accomplished ranging from the New Port now over half completed, increasing the number of districts slated for development from 18 to 23, to the selection of Yongwon(Muhak)-STX Consortium as the selected bidder for the Ungdong Tourism Complex. In spite of the success of de-regulation with the augmentation of FEZ Law as special Law more needs to be done; government red tape slows the entry of foreign investors and land development costs still impede the attraction efforts of the BJFEZA front line staff. To this end, the BJFEZA is continuing to pressure the central government for realistic measures to assist the BJFEZ in achieving its full potential.

Hwajeon district's latest entry-LS Industrial Systems

April 2nd-Hwajeon district, located in the Busan-Jinhae Free Economic Zone will be home to LS Industrial's latest plant fabricating stainless steel pipes and electronic equipment for the area's manufacturers. The 41,015 m² facility is located on 108,437 m² of land which was purchased by LS Industrial.

200 people are expected to take part in the inaugural opening of the facility. Special guests include Hur Nam-sik, the Mayor of Busan Metropolitan City, the Chairman of the Busan Chamber of Commerce and Industry as well as National Assembly Representatives Heo Tae-yul and Park Min-sik along with the Deputy Commissioner Song Geuno-il representing the BJFEZ Authority.

Hwajeon district is a strategic location for the BJFEZ due to its proximity between Sasang-gu, Busan and Geoga bridge. This proximity to Geoga bridge as well as Renault-Samsung puts companies involved in shipbuilding as well as auto parts in a prime location which will serve to enhance business efficiencies such as reduced logistics costs and easy access via all transportation modes for staff as well as customers served by LS Industrial.
